**Kristin Antelman** is Associate Director for the Digital Library at NCSU Libraries. Prior to joining NCSU in 2002, she worked at the University of Arizona Health Sciences Library and the University of Delaware. She received her MLS from the University of Chicago. She has long been interested in issues related to serials and electronic resource management. She is NCSU's representative on the Kuali OLE Functional Council and is PI on a new collaborative project between Kuali OLE and JISC to build a Global Open KnowledgeBase.

**Jane Bethel** manages electronic resources as a UNC-Chapel Hill School of Information and Library Science (SILS) contractor for the Environmental Protection Agency (EPA) in Research Triangle Park, North Carolina. She manages the serials collection; ensures the acquisition and access to journals; collects statistics and evaluates renewal subscriptions; assists online literature searches and provides reference; analyzes and coordinates license agreements; trains, administers activities, and mentors graduate interns.

**Denise Branch** is the Assistant Head of Acquisitions and Serials Librarian at Virginia Commonwealth University in Richmond, Virginia. She has held this position for eight years. She oversees licensing, ordering, receiving and maintenance of the electronic serials collection and is responsible for administrative management of the SFX KnowledgeBase. She manages the answering of e-journal problem reports for the Acquisitions Dept. Denise received her MSLS from Catholic University.

**Sarah Brett** is the E-Resources/Serials Manager at James Madison University Libraries in Harrisonburg, Virginia. She has held this position for nearly 4 years, overseeing the ordering, budget, troubleshooting, maintenance, and cataloging for electronic resources and print serials. As part of her work as manager, she has spent a great deal of time thinking about how the E-Resources unit can be best organized to handle the growing demands of electronic resources.

**Elizabeth Coleman** is pursuing a master's degree in Library Science from the University of North Carolina at Chapel Hill. She is currently working as an UNC-Chapel Hill contractor intern at the Environmental Protection Agency (EPA) Library in Research Triangle Park, North Carolina.
